We work with entrepreneurs, investors, policy experts, governments, humanitarians, and new city developers to build a common understanding of charter cities and create relationships which can work towards implementing charter cities. Our goal is to lift tens of millions of people out of poverty by helping to incubate dozens of charter cities around the world.

Charter Cities Summit: We organized a day long charter cities summit in San Francisco with eight speakers and 30 attendees. The attendees were quite pleased with the quality of the event and the topic of discussion.

4b (Code:) (Expenses \$ 158,682 including grants of \$) (Revenue \$)

Charter Cities Business Plan Contest: We organized a Charter Cities Business Plan Contest to identify potential partners who were building new cities. Enyimba Economic City, a 95 square kilometer new city being built for 1.5 million residents won first place. Second place is Blackstone Charter Cities, an early stage charter city development in Australia. Third place is Novrogod New Hanse Town, an early stage Russian charter city development. We have subsequently worked with Enyimba Economic City to draft their regulations which we expect to be submitted to the Nigerian Export Processing Zone Authority in the coming months.

Memorandum of Understanding with the Zambia Development Agency: We worked much of last year, including visiting Zambia in and hiring a consultant to negotiate a memorandum of understanding with the Zambia Development Agency, to help them rewrite their special economic zone legislation. The memorandum of understanding was signed on February 18th, 2020.
