We work with entrepreneurs, investors, policy experts, governments, humanitarians, and new city developers to build a common understanding of charter cities and create relationships which can work towards implementing charter cities. Our goal is to lift tens of millions of people out of poverty by helping to incubate dozens of charter cities around the world.

Governance Handbook: We researched and drafted a Governance Handbook that provides step-by-step guidance for creating a legal system from scratch. This Handbook covers 16 different regulatory domains that are essential for effective urban governance, and provides policy recommendations for each domain. Research included conducting over 50 interviews with practitioners and academics across all regulatory domains covered, receiving feedback and comments on early drafts of the Handbook, incorporating this information, and finalizing for publication.

Enyimba Economic City - Draft City Regulations: We provided technical assistance to a new city project in Nigeria called Enyimba Economic City (EEC). This technical assistance included helping the EEC legal team draft EEC's City Regulations. These City Regulations were submitted to the Nigerian Export Processing Zone Authority for approval and ultimately gazetted into law.

Reference Guides: We wrote and published several reference guides for city developers and governments interested in building charter cities. These documents --including a Model Charter, Model Enabling Legislation, a Risk Mitigation Guide, and an Introduction to Charter Cities -- can serve as the foundation for stakeholders involved in building a charter city. We will add to these Reference Guides this year by providing Model Regulations (aligned with the various policy recommendations from the Governance Handbook), a Model Public-Private Partnership Agreement, and a Model Land Agreement.
